<b>1</b>	<b>Husband</b>			Must be legally married. Secret or undocumented marriages are not eligible.
<b>2</b>	<b>Wife(s)</b>			Multiple wives are eligible. Secret or undocumented marriages are not eligible. A divorced wife is eligible if iddah period has not yet completed.
<b>3</b>	<b>Sons</b>			Adopted son, step-son, or illegitimate son is not eligible.
<b>4</b>	<b>Daughters</b>			Adopted daughter, step-daughter, or illegitimate daughter is not eligible.
<b>5</b>	<b>Father</b>			Illegitimate father, or step-father is not eligible.
<b>6</b>	<b>Mother</b>			Illegitimate mother, or step-mother is not eligible.
<b>7</b>	<b>Sons of Sons</b>			Only son's sons are eligible. Daughter's sons are not eligible.
<b>8</b>	<b>Daughters of Sons</b>			Only son's daughters are eligible. Daughter's daughters are not eligible.
<b>9</b>	<b>Father (or higher) of Father (Grandfather) P</b>			Only father's father is eligible. Mother's father is not eligible.
<b>10</b>	<b>Mother (or higher) of Father (Grandmother) P</b>			Father's mother is eligible.
<b>11</b>	<b>Mother (or higher) of Mother (Grandmother) M</b>			Mother's mother is eligible.
<b>12</b>	<b>Great Grand Sons</b>			Only son's sons sons are eligible. Daughter's sons are not eligible.
<b>13</b>	<b>Daughters of Great Grand Sons</b>			Only son's daughters are eligible. Daughter's daughters are not eligible.
<b>14</b>	<b>Great Grand Father</b>			Only father's father father is eligible. Mother's father is not eligible.
<b>15</b>	<b>Great Grand Mother</b>			Mother's mother is eligible.
<b>16</b>	<b>Father of Great Grand Mother</b>			Only father's father father is eligible. Mother's father is not eligible.
<b>17</b>	<b>Mother of Great Grand Mother</b>			Mother's mother is eligible.
<b>17</b>	<b>Full Brothers</b>			Brothers who share the same father and the mother with the deceased.
<b>18</b>	<b>Full Sisters</b>			Sisters who share the same father and the mother with the deceased.
<b>19</b>	<b>Half-Brothers from Father (Consanguine)</b>			Brothers who share the same father, but a different mother.

<b>20</b>	<b>Half-Sisters from Father (Consanguine)</b>			Sisters who share the same father, but a different mother.
<b>21</b>	<b>Half-Brothers from Mother (Uterine)</b>			Brothers who share the same mother, but a different father.
<b>22</b>	<b>Half-Sisters from Mother (Uterine)</b>			Sisters who share the same mother, but a different father.
<b>23</b>	<b>Full Brother's Son (Nephews)</b>			Only brother's son is eligible. Sister's son is not eligible.
<b>24</b>	<b>Consanguine Brother's Son (Paternal Nephews)</b>			Only Paternal brother's son is eligible. Paternal brother's daughter is not eligible.
<b>25</b>	<b>Full Brother's Son's Son</b>			Full brother's son's son.
<b>26</b>	<b>Consanguine Brother's Son's Son</b>			Paternal brother's son's son.
<b>27</b>	<b>Full Uncle</b>			Father's full brother.
<b>28</b>	<b>Consanguine Uncle (Paternal Paternal)</b>			Father's paternal brother.
<b>29</b>	<b>Full Uncle's Son</b>			Father's full brother's son.
<b>30</b>	<b>Consanguine Uncle's Son</b>			Father's paternal brother's son.
<b>31</b>	<b>Full Uncle's Son's Son</b>			Father's full brother's son's son.
<b>32</b>	<b>Consanguine Uncle's Son's Son</b>			Father's paternal brother's son's son.
